- The Wadia'h Diaspora Mortgage Saving Account is local currency account to which deposit shall be made in foreign currency (USD,GBP or EUR)
- Withdrawals from this account are permissible only in local currency. However, the applicant shall continue the monthly deposit until the required equity contribution is fulfilled.
- This account shall not bear any financial return /benefit in the form of profit sharing However,it shall only serve as an eligibility criterion for IFB Diaspora Mortgage Financing service.
- The Bank reserves the right to close the account or disqualify the applicant from Diaspora Mortgage Loan eligibility if there is local currency credit transaction to the account.
